AFL Tipping 2019

Terms and Conditions of Entry

1. Terms and Conditions: Information on how to enter and prizes form part of these Terms and Conditions of Entry.
2. Promotion Period: The promotion valid 2019 AFL Home and Away Season
3. Eligibility: Entry is open to residents of Australia aged 18 years and over. Staff or Management are not permitted to take part in this promotion.
4. How to Enter: The 2019 footy tipping competition is a joint competition involving entrants from both Bentleigh RSL and Bentleigh RSL – Cheltenham Campus and patrons are to see bar staff to register at a cost of \$25 being the entry fee. The entry fee can be paid by cash or RSL Reward Points.

Entrants must submit tips prior to the first game of each round at the nominated venue. The venue will supply entrants with a 2019 Footy Fixture to place their tips. In the event that an entrant does not enter their tips for the week prior to the first game of the round the entrant will receive the lowest score recorded by an entrant for that week. Weekly tips will not be accepted via the means of email, phone or other without prior authorisation from promoter, entrants must complete tips in venue. Entrants may tip for weeks in advance.

When filling in tips the entrant must cross out the team it anticipates to lose the designated match. Management will enter entrant's results each week via google forms and then update leader boards. The leader boards will display the running top 10 entrants each week on our Facebook page as well as internal leader boards via digital display at both campuses so entrants can check their results on a weekly basis. All entrants' results will be made available at each site concluding the round.

5. Total Value of Promotion: Bentleigh RSL shall supply two (2) 2019 AFL Grand Final Tickets. The value of the prize pool shall be determined by the number of entrants made up of the original \$25 per entrant fee
6. Prize Breakdown: The prize pool will be structured as:

1st Place: 2 x 2019 AFL Grand Final Tickets and 40% of Final Pool

2nd Place: 40% of Final Pool

3rd Place: 20% of Final Pool

In the event of a tie the prize pool will then be split accordingly.

In the event that there are multiple on the top score, a countback to the entrant with the most perfect rounds shall occur, with this entrant winning 1st Place and all others 2nd Place. Should there still be a tie under this circumstance the countback will continue down on weekly results until a winner is determined. In the event that identical results have occurred the winner will be the entrant that entered the tipping competition at the earliest date or time.

1 x Winner 1st Place and 2 x Winners 2nd place – 1st place will receive 1st prize with 2 x 2nd places sharing 2nd and 3rd place, No prize for 3rd place

1 x Winner 1st place and 3 or more winners 2nd Place - 1st place will receive 1st prize with all winners in 2nd place sharing 2nd and 3rd place, No prize for 3rd place

1 x Winner 1st Place, 1 x Winner 2nd place and 2 or more for 3rd place – Winner of 1st and 2nd will receive their relative prize and all winners of 3rd place will share 3rd prize value

7. Promoter's decision final: In the event of a dispute concerning the conduct of the promotion, the decision of the Promoter is final and no correspondence will be entered into.
8. Release: The Promoter shall not be liable for any manufacturer defects in prizes or for any loss, damage or personal injury whatsoever which is suffered or sustained (including but not limited to indirect or consequential loss) as a result of taking a prize, except for any liability which cannot be excluded by law.
